



## Lillooet Rod and Gun Club – Range and Safety Procedures

---

Welcome to the Lillooet Rod and Gun Club. Memberships are valid from April 1<sup>st</sup> of the current year to March 31<sup>st</sup> of the following calendar year. Club meetings are at the Lillooet Rec Centre on the 1<sup>st</sup> Tuesday of every month, excluding July and August, at 6:30 pm but are subject to change due to weather or relocation to the range. Membership processing is usually completed immediately upon receipt of the application form and membership fees.

### **Range Procedures:**

- **Max caliber allowed on Rifle Range is 338 Lapua, Handgun Range 357/9MM**
- Only current (paid) Lillooet Rod and Gun Club members and paid, registered guests may use this range.
- **REMEMBER TO SIGN IN WITH YOUR MEMBERSHIP NUMBER OR NAME**
- The sign-in book is located in the white metal box. This is your record of range use should the Chief Firearms Officer need this information. This is especially important for those members with restricted firearms.
- All guests of members require insurance by way of purchasing a GUEST PASS. Guest Passes are available for \$5.00 per day. Guest passes can be emailed to you via [lillooetrodandgun@gmail.com](mailto:lillooetrodandgun@gmail.com) or [membershiplillooetrodgunclub@gmail.com](mailto:membershiplillooetrodgunclub@gmail.com). Passes can also be found in the box near the gate at the range. Guests MUST be accompanied to the range by the Member Sponsor. Leave completed passes and fees in the lock box inside the box near the gate.
- All minors, guests and Junior Members must be under direct supervision of current (paid) member.
- Spectators attending activities are not insured and are in the gun range at their own risk.
- Children must be accompanied by their parents or a responsible adult at all times.
- All members must prominently display their membership card on their person or be prepared to be asked to produce it if requested by any club member. Guests must produce their guest pass when requested by any club member.
- Members are expected to bring their own ammunition including clay pigeons to the range and to the weekly activities. The Club does not sell ammunition; it is available for purchase at Winner's Edge.
- Depending on availability, the Club may supply ammunition for the weekly and public shoots at a small fee to the participant.
- Members are expected to supply their own paper targets.
- Close and lock the gate after entering or upon leaving range to prevent access by unauthorized persons. Be sure to spin the dials on the combination lock after closing the padlock.
- The **RED FLAG**, located in the box near the gate, must be raised when the range is in use. The last member leaving the range must lower the flag and replace it in its box.
- When there are two or more persons using the range, one member must act as a Range Officer to ensure safety on the firing line.

### **Range Procedures: (continued)**

- No drugs or alcohol allowed.
- All members are asked to **observe, record and report** any incidents of abuse of the range rules or range improvements to the LRGC executive.

### **Range Safety:**

- Eye and hearing protection is highly recommended when shooting or when near the shooter.
- Firearms must be unloaded except on the firing line.
- Everyone is to be behind the firing line before shooting commences and during shooting.
- Firearms must be unloaded with actions open when at or behind the firing line whenever anyone is down range.
- No centre fire rifles on the pistol range.
- All targets must be range approved.

### **Do Your Part to Keep the Range Clean:**

The range is operated and maintained by club members on a voluntary basis for the benefit of all other club members. **ALL CLUB MEMBERS** share the responsibility of maintenance and upgrades. Please do your part by:

- Removing your targets from target boards and disposing of them in the barrel.
- Picking up your spent brass and shot shells. Dispose of them in the barrel or take them home.
- Leave the range as clean--or cleaner--than you found it.

**Remember that your behavior on the range and the condition you leave it in will determine if this range will continue to exist.**

### **Member Insurance:**

As a paid member, except for Business Memberships, you are covered under insurance issued through Canada's National Firearms Association. **Once your application has been processed**, your insurance coverage is valid **anywhere in the world** for:

- All legal hunting activities;
- All legal bowhunting activities;
- All legal range shooting activities;
- All legal range archery activities;
- All legal fishing activities;
- All legal re-enactment activities;
- All National Firearms Association sanctioned activities.

**This insurance does not cover business activities, activities involving horses, activities involving ATVs or unsanctioned activities such as but not limited to 3D Archery, Paintball or Archery Tag.** Commercial general liability coverage is \$5,000,000 with a \$500 deductible for situations involving bodily injury, property damage and legal expenses.

Always remember to practice safe firearms handling by practicing **ACTS** and **PROVE** it:

**ACTS** – **A**ssume every firearm is loaded; **C**ontrol the muzzle; **T**rigger finger is off the trigger; **S**ee that it is safe.

**PROVE** – **P**oint firearm in safest direction; **R**emove all ammunition; **O**bserve the chamber; **V**erify the feed path;

**E**xamine the bore.

Failure to follow Range Rules and Safety Procedures may result in membership termination by LRGC Executives.
